#### Off to a good start...




- 225 Forums

- 177 Forums or Prospective Forums awarded grant and/or technical support by Government via Locality from April 2015 – March 2019
- Around 1,500 Town/Parish Councils supported during that period

- One Forum from each of the 84 LPA areas featured in the 177
- Added a further 16 to round it up to 100
- 6 minute online survey of Forum websites
- How many of the 6 tests are met: yes or no answer for each
- Note made of any policies/procedures of interest
